

A RECENT ADDITION TO OUR PHOTOGRAPH COLLECTION

Newspaper headlines announced the Northwest "paralyzed by Heavy Snow." The storm on February 1 and 2, 1916 dropped over 21 inches on Seattle and an estimated three to five feet of snow on Stanwood. *The Seattle Post-Intelligencer* proclaimed that the "white menace . . . played havoc with the peaceful traffickings . . . of man."

The H & H Railroad company was the mile long railroad that hauled goods and passengers from Stanwood to the Great Northern Railroad depot in East Stanwood. In the beginning, the H & H, built by John W. Hall in 1904, connected both the waterfront mills and passengers to the train station with the Stanwood Lumber Company its prime client. According to Alice Essex the ride for passengers was sometimes fearful but also wonderful, and residents loved having the little engine and its cars waiting to transport them across the "muddy mile" to Stanwood's Main Street. Passenger service was discontinued, however, around 1918. The street car shown in the picture was purchased from the Seattle street railway company. The H & H operated when needed for freight in the 1930s and made its last run

in 1938. It was dubbed the "shortest railroad in the world" by news media of the day.

A Posthumous Victory for Veterans' Rights


Flags no longer snap in the wind atop the two rusty poles sitting back from the street just south of Highway 532, in a field adjacent to a Park and Ride. Nor do they call attention to the plaque sitting nondescriptly beneath them on dull, gray stone slabs. No one stops to read the name Frederick G. Eglinton which rises from that plaque or the sentiment it marks: Veterans of Foreign Wars, Post 2586, 1932 – 1982. The memorial, however, carried the hopes of its benefactors that people might remember the young man from Bellingham whose name became synonymous with the Stanwood post for fifty years before its assimilation by nearby American Legion Post 92.

No words describe Eglinton's war disability or early death in August 1921 at the age of 23 or the pulmonary tuberculosis which ravaged his body a year before; a disease which Eglinton and his family directly linked to the gas attack in France he endured during World War I. Initially a member of the 2nd Coast Artillery of the Washington National Guard, Eglinton's unit was nationalized as the 65th Coast Artillery shortly after America's entrance into the global conflict. Eglinton was honorably discharged from his unit at Camp Lewis on February 28, 1919 upon his return from Europe. He lived for only another 29 months.

Eglinton filed a claim for insurance benefits shortly after his discharge citing his permanent disability. He had maintained his insurance policy with monthly payments during his military service which was to provide \$10,000 in benefits as mandated by the War Risk Insurance Act of 1914 and 1917 and administered by the Treasury Department of the federal government. However, the payments were never honored by the Bureau of War Risk Insurance.

Although too late to benefit Frederick Eglinton, his parents, with the help of the American Legion state Adjutant Jesse W. Drain, sued the government in 1925 for the money owed their son claiming negligence or fraud by the Veterans' Bureau. Drain had been a lieutenant in Eglinton's unit in France and his growing reputation would mark him as one of the leading activists for veterans' rights on the Pacific coast. Through petition William and Trina Eglinton made Drain administrator of their son's estate and, as such, he joined in the lawsuit as a plaintiff. Newspapers claimed the suit the first kind of record in the federal court. The same year as the lawsuit, a columnist for H. L. Mencken's American Mercury magazine wrote that, "Congress little realizes that its creature, the Veterans Bureau, has probably made wrecks of more men since the war than the war itself took in dead and maimed."

A year after filing, a federal jury awarded the estate of Frederick Eglinton the full amount of his policy along with a lump sum due the young soldier from the time of his discharge in 1919. William and Trina Eglinton remained active in their efforts on behalf of veterans of northwest Washington. The Stanwood VFW Post 2586 was dedicated on July 1932, coinciding with demonstrations in Washington, D.C. by World War I veterans, dubbed the Bonus Army, demanding early redemption of promised payments as many struggled during the Great Depression. Federal troops forcibly dispersed the veteran encampments killing at least three people. Although Fred Eglinton was not there with them, the lawsuit argued in his name puts him in the ranks of those who fought not only for their country, but for the rights promised them upon their return.
